POLICY ON VICTORIAN REFEREES OFFICIATING INTRASTATE AND INTERSTATE

INTRASTATE TOURNAMENTS:

All VBRA Registered referees intending to officiate in another VICTORIAN tournament, outside their home Association, are required to have submitted a form of approval.

The form must be completed, signed and submitted to the Home Association, no less than one week prior to attending the tournament.

Both the Branch and the Referee are advised to keep a copy of the completed form.

INTERSTATE TOURNAMENTS: (Domestic Competition)

All VBRA Registered referees intending to officiate in another STATE tournament, are required to have submitted a form of approval.

The form must be completed, signed and submitted to the Home Association, and the VBRA no less than one week prior to attending the tournament.

Both the Branch, the VBRA Administrator and the Referee are advised to keep a copy of the completed form.

The tournament can do its own recruiting and make its own arrangements with the referees, as long as the form is submitted.

INTERSTATE TOURNAMENTS: (Championship Competition)

All VBRA Registered referees wishing to officiate in another STATE CHAMPIONSHIP tournament, must be invited by the VBRA in conjunction with the interstate controlling body.

Upon an approach from an interstate controlling body, the VBRA will seek and approve nominations from interested officials, and forward this information on to the interstate controlling body.

The VBRA then will require the nominated registered referee to complete, signed and submit to the Home Association, and the VBRA no less than one week prior to attending the tournament.

Both the Branch, the VBRA Administrator and the Referee are advised to keep a copy of the completed form.
