How do I access GIO Workers Compensation?

New Business Policies

The "Application for a WorkCover Insurance Policy" form (New Business Application form) can be downloaded from the GIO website (www.gio.com.au). It should be printed and completed in full.

1. The form should then be sent to:

GIO Workers Compensation Victoria will process new business applications within 15 calendar days.

If a certificate of currency is needed at commencement of the policy, a separate request is required. This can be made by contacting the Premium Services Team on 03 9860 3555.

Transfer Existing Policies

- The "Request for Change of Authorised WorkCover Agent" form (Transfer form) is available on the GIO website (www.gio.com.au). It should be printed and completed in full.
- 2. The form should be sent to Premium Service Team. (See above address).

Note: Employers are only qualified to transfer their policy if:

- 1. They have NO outstanding premium instalments.
- 2. They have been with their current agent for at least 12 months

The transfers are actioned on the 1st working day of the month following receipt of the "Request for Change of Authorised Workcover Agent" form. This is subject to the form being received no less than 5 working days before month-end.
