PLEASE NOTE: A PLAYER CAN ONLY BE REGISTERED FOR ONE FORM OF FOOTBALL WITH ONE CLUB AT A TIME – e.g. a person CANNOT be registered with 2 eleven-a-side clubs at the same time during a season, unless permitted under Section 4.9(b) of the National Registration Regulations, including an exemption granted by FFA.

Providing false or misleading information could result in the immediate cancellation of the registration. This original form will be sent to FFA. Please ensure that photocopies are taken for the Participant, the Club/Referee Organisation and/or the Competition Administrator.

All information contained on this form is to be entered into the designated system by the Competition Administrator or Member Federation unless agreed otherwise. If any of the details on this form change, the Competition Administrator or Referee Organisation is to be immediately notified.


