## Under 12's Competition Format 2013

Due to the large number in the Under 12's age division, the Far South Coast Executive Committee (FSCFA) have made the following amendments to the competition for 2013.

Under 12's - 10 Registered teams.

- 1. Each team will play each other once in the first 9 Rounds.
- 2. For the purpose of the remainder of the competition, the 10 teams will split into two pools.
- Pool A First 5 teams- as per ladder at the completion of Round 9, 30 June 2013.
- Pool B Next 5 teams as per the ladder at the completion of Round 9, 30 June 2013.
- 3. The ladder for all teams will reset to zero (0) at the completion of Round 9, 30 June 2013.
- 4. For the purpose of identifying the minor Premiers, all points earned during the 2013 season will be held and carried.
- 5. There will only be one (1) Minor Premier per age division.
- 6. It was decided that teams would be allocated the following "reward" ladder points leading into phase 2 of the competition fixtures commencing on Sunday July 21st.

- 9. There will be two Under 12 Finals. Pool A and Pool B will contest their own finals series.
- 10. For the purpose of finals, the standard rule 12.2 (as per FSCFA Competition rules) will apply to both pools.

## Under 14's Competition Format 2013

Due to the large number in the Under 14's age division, the Far South Coast Executive Committee (FSCFA) have made the following amendments to the competition for 2013.

Under 14's - 9 Registered teams.

- 1. Each team will play each other once in the first 9 Rounds.
- 2. For the purpose of the remainder of the competition, the 9 teams will split into two pools of either 5/4 or 4/5 dependant on ladder positions and points.
- Pool A First (TBA) teams- as per ladder at the completion of Round 9, 30 June 2013.
- Pool B Next (TBA) teams as per the ladder at the completion of Round 9, 30 June 2013.
- 3. The ladder for all teams will reset to zero (0) at the completion of Round 9, 30 June 2013.
- 4. For the purpose of identifying the minor Premiers, all points earned during the 2013 season will be held and carried.
- 5. There will only be one (1) Minor Premier per age division.
- 6. It was decided that teams would be allocated the following "reward" ladder points leading into phase 2 of the competition fixtures commencing 14th July for 4 team Pool.
- 7. The pool split will be decided at the completion Round 9, the FSCFA Executive will review team placements and decide on pool allocations for the remainder of the season.
