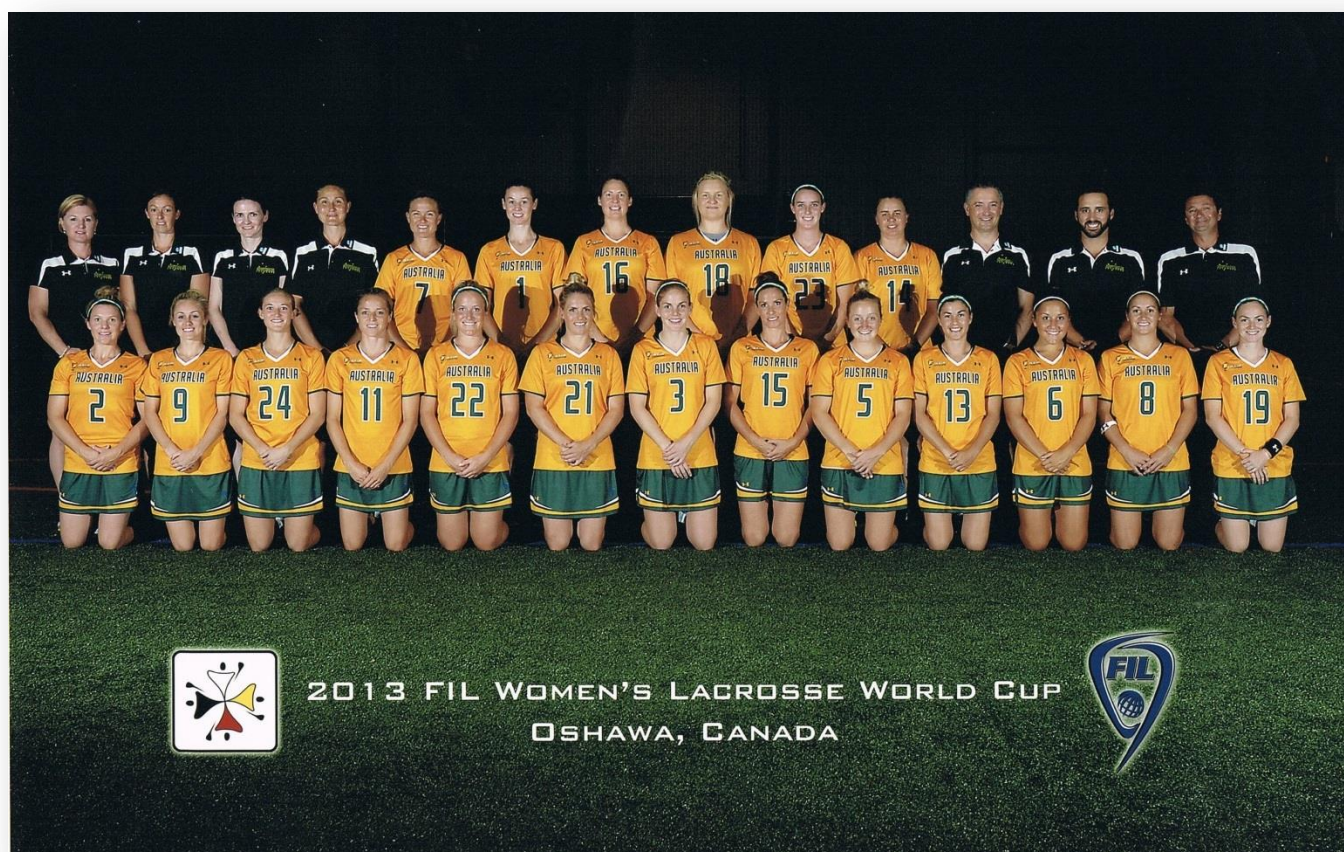

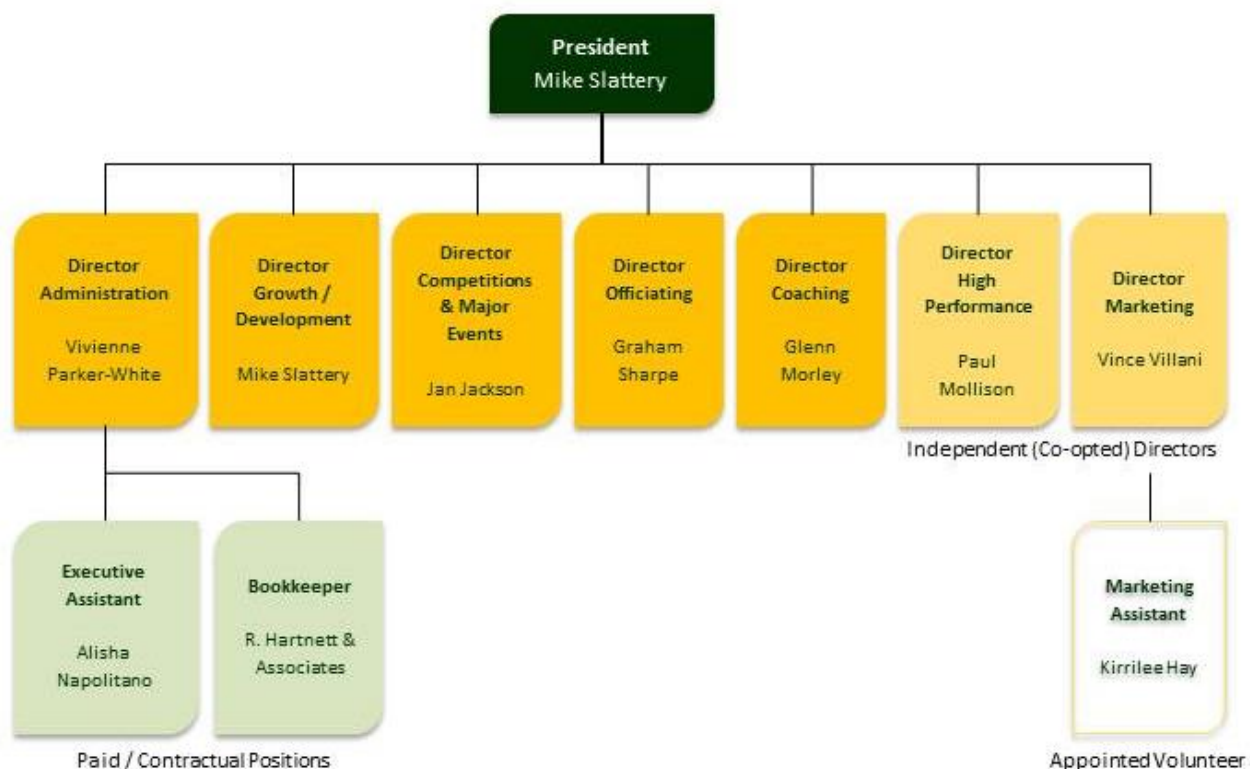

Message from ASC CEO Simon Hollingsworth

The first quarter of 2013 has been a busy period for Australian sport. We continue implementing Australia's Winning Edge and I'm grateful for the cooperation of our sports partners as we advance this strategy.

One of the most important items on our current agenda is the upcoming announcement on funding for sports.

Throughout February and March we asked sports to present their High Performance Cases outlining how they will contribute to achieving the medal targets set out in Australia's Winning Edge. This has allowed us to develop a set of high performance recommendations for the consideration of our Board, with funding outcomes to be announced in the near future.

This activity is on top of a series of significant announcements and events since my last message.

Importantly, we have identified a set of mandatory Governance Principles. With improvement in governance now linked to ASC funding grants, this will significantly improve accountability in Australian sport, providing dividends for both Australia's high performance success as well as grass roots participation.

We have also released two significant research reports. The Future of Australian Sport report was conducted by the CSIRO on behalf of the ASC and identified six megatrends that are likely to shape sport over the next 30 years. The Market Segmentation for Sport research examines the motivators and barriers that underpin Australians' decisions to participate in sport. Both are important contributions and will guide how sport is approached in the coming years.

We have also now sought applications for three exciting programs. The AIS Centre for Performance Coaching and Leadership will launch its inaugural Performance Coach and Performance Leaders programs in May, while the Sport Leadership Grants and Scholarships for Women provides women involved in sport with leadership development opportunities. Similarly, the Multicultural Youth Sports Partnership program looks to create opportunities for young people in new and emerging communities to participate in sport. I encourage anyone who is eligible to apply for these opportunities.

In the wake of the very successful Our Sporting Future Forum 2013 — where the long-term sustainability of sport was discussed — there is another not-to-be-missed event on the horizon. For those who will be in Canberra on Sunday 28 April, you will have a chance to unravel the mystery behind Australia's high performance athletes at the AIS Open Day. I hope to meet many of you on the day to celebrate what is a momentous year for Australian sport.

President's Report

Mike Slattery

In the current sporting scenario within Australia and internationally the ALA currently must balance continuing its sound and effective Governance with an accelerated Growth of our sport (measured across members and participants) whilst addressing the remaining targeted Key Result Areas. ALA must continue to strengthen the foundations of our sport, an area we certainly can claim historical excellence, whilst ensuring increased participation in all levels of lacrosse (players, coaches, officials, administrators, supporters), an area that provides us with significant challenges.

This priority focus is supported by the ALA's Operational and Strategic Plans and will respond to the priorities requested by the Member Associations. We reassert this focus while concentrating upon delivering new and improved services to members.

The continued support of the Australian Sports Commission (ASC) is acknowledged and continues to be integral to the successful operations of lacrosse on this country. The annual ASC review of ALA operations against 'plan' continues to be positive and result in ongoing assistance, both financial and expert assistance.

International success continues to flow from FIL (Federation of International Lacrosse) competition with the Senior Women's Team earning a bronze medal in this year's World Cup held in Oshawa, Canada, in an increasingly competitive environment. Our challenge is to maintain our quality of performance from a small playing base while the majority of our competitors have greatly enhanced their quantity of players (and hence their competitiveness). Australia is represented on FIL Committees (e.g. Chair of Women's Rules - Jan Jackson, Men's Rules Committee - Chris Brown, Women's Rules Committee - Paul Mollison) and it is important, as a founding nation of the FIL, that we now continue to contribute and lead the way.

Regional success has been earned from the APLU (Asia Pacific Lacrosse Union) with both men's and women's teams earning silver medals at this year's ASPAC (ASia PACific) Championships held in Beijing, China. Again Australia, as the longest developed lacrosse nation in this region, must continue to contribute as they currently are (e.g. Fiona Clark, Executive Director and Mike Slattery, President of the APLU Executive Board).

Some major and new milestones achieved in this last year include:

- Financial management being exercised via a CPA firm with formal audit;
- Recognition being achieved via the annual dinner with the Honours & Awards Committee instituting formal recognition of past formal international men's and women's teams;
- Establishing a national insurance scheme with economies of scale resulting;
- Establishing an East Coast Tournament (i.e. NSW, Queensland, Tasmania) for competitive development of the less experienced States;
- Holding an inaugural National Conference (initially Coaching and Officiating);
- Near completion of the establishment of a Lacrosse Foundation (for the ongoing fund raising and support of lacrosse development);
- Piloting a successful national travel partnership (with both competitive economies and rebates being achieved);
- Piloted Sporting Pulse online registration and competitive results which ultimately will provide full participant statistics (via the databases supporting these initiatives).



Successful Presidents', Competition and Growth Forums were held with Member Associations during October in a co-operative and challenging environment. It is acknowledged that such opportunities result in openness and challenge during these events, with resulting accountability shared between Member Associations and the ALA, which is then essential for the success of lacrosse in Australia.

I thank and commend the directors of ALA for their diligence and significant contributions to the Board and the sport of lacrosse. Their voluntary efforts are significant, in both effectiveness and effort, and well directed towards maintaining success to date – this being balanced with meeting the challenges of the future. Similarly, thanks are expressed to the Boards and directors of the Member Associations without whose efforts and co-operation lacrosse would not and will not prosper in Australia.

As we look to the future of lacrosse in Australia it is clear that the ALA and Australian lacrosse continue to be challenged. Collectively we have an exciting opportunity for our sport ahead of us and I am sure we will all rise to meet those challenges with the ultimate outcome being the betterment of lacrosse in Australia and elsewhere.



Marketing Report

The major ALA marketing initiative which has been progressed during 2013 has been a redevelopment of the front-end of the ALA website. This has been modeled on the current Lacrosse Victoria website and hence presents a better marketing image with integrated social media feeds. It does not replace (rather it complements) the Sporting Pulse capabilities that are provided for the ALA database (and all State Member Associations) of participation and contest results. It is due to launch in late November 2013. Development has been progressed by the incumbent ALA Director of Marketing (Vince Villani) and Brownstone Consulting (Dan Prior) and is currently in final preparations for cutover.

The ALA Director of Marketing, Vince Villani, was appointed in December 2012 to this Independent Director position. This had been sought externally, as well as within, the lacrosse community to give greater focus on improving the growth and awareness of lacrosse within Australia. Due to work and family commitments the ALA Board has recently (28 October 2013) regrettably accepted Vince's resignation.

Also in December 2012 ALA appointed Kirrilee Hay to the position of Assistant to the Marketing Director. This is a voluntary position and Kirrilee is about to take on the overseeing of the ALA social media tools of Facebook and Twitter linked to the new (during November 2013) ALA website, as well as assisting in other relevant areas.

ALA is currently re-assessing their Marketing Director position in light of the October 2013 Forums (Presidents, Competition and Growth as held by ALA Directors with member state Executives) which resulted in a number of key issues being addressed. It was agreed that lacrosse marketing and communication is a very high priority and must be successfully progressed. An ALA Director of Marketing is undoubtedly required on the ALA Board. However it is believed that necessary support must be provided to that role in creating and delivering the marketing plan – which is seen initially necessary to establish a working framework for marketing. The ALA Board has subsequently decided to fund and seek the employment of a marketing project officer early in 2014, to initiate the establishment of the ALA marketing plan, who will be overseen by the new ALA Director of Marketing.

Work was begun on a plan to address how the ALA can grow participation numbers and improve its overall profile at both a state and national level. This marketing plan and activity is absolutely necessary to support the ALA Growth and Development activities that have taken place to date and those that are planned for the future.

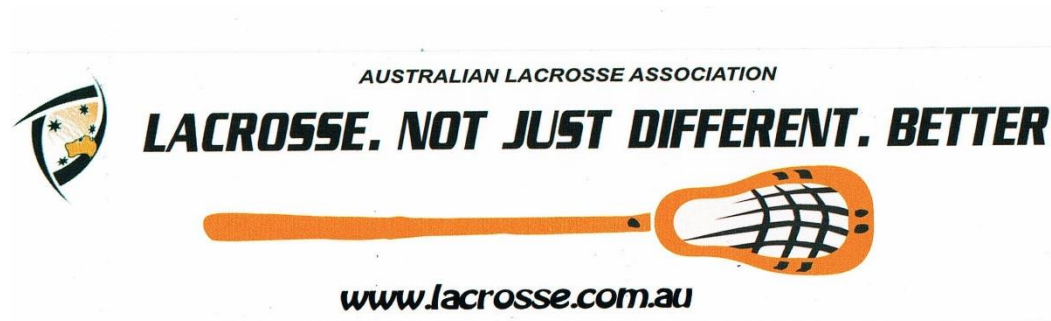
In 2012 the following points were agreed (and they remain) as the foundation for the ALA's marketing plan:

- Creation and sharing of resources among all Member Associations
- Use of social media tools
- Better collaboration between Member Associations
- Increased communication
- Sponsorship opportunities progressed
- Publicity generated for lacrosse and particularly for any specific opportunities

In 2013 work continues on those listed points with great improvement having been gained through Member Association consultation and the sharing of ideas and experiences. The outcome that more than one (1) annual Presidents Forum is desired by all is very much welcomed by ALA. Hence that increased collaboration and communication will optimise top down planning for lacrosse in Australia.



ALA announced the ALA 'tag' line "**Lacrosse. Not just different. Better**" in 2012 and is extremely pleased with its reception and use to date. Acknowledgement is made to the then ALA Director of Marketing (Diane Harari) who designed and architected this development. Currently there are transfers and fridge magnets available for lacrosse people (via their State associations or the ALA) to use in supplementing the exposure of lacrosse in Australia.



High Performance Report

Paul Mollison

Development and improvements to the Australian Team programs, remains the main focus of the High Performance portfolio. Increasing the competition opportunities for Australian teams, has been achieved with the scheduling of the Senior National Championship in June, prior to FIL and APLU events, most often held in the northern hemisphere summer of July.

The inclusion of Japan (men) and New Zealand (women) at this year's National Championship in June, provided high level competition for state teams, followed by welcomed international competition for our Australian Teams. The return tour of our Australian Men's Team to Tokyo Japan, is scheduled for February/March 2014.

High Performance Program Policy

During October, a revision and upgrade of the HPPP now provides policy direction for Australian Teams for the period 2014 – 2016. An increase of the preparation duration of Australian team programs is the most significant change.

U23 Australian Men's Team 2013 and U23 Australian Women's Team 2013

With the formalising of an ongoing 'middle' level between U19 and Senior Australian Teams, the U23 program provides opportunity to many young lacrosse athletes, for HP preparation and competition. With many of our talented lacrosse athletes missing selection to the U19 programs, either by age qualification or as a 'late bloomer', the U23 program and the APLU ASPAC event will ensure an increase of the talent pool for future selection to senior Australian teams.

The 2013 U23 team gathered in Melbourne for competition in the Down Under Cup tournament. They then travelled as one group to Tokyo Japan for the Friendship Games, then headed to Beijing China for the 2013 ASPAC Championship. The success of Silver Medals by both teams at the ASPAC Championship, was highlighted by competing in three events, in three countries, over three weeks.

Australian Women's Team 2013

The 2013 FIL World Cup approached with high expectations, given the Gold Medal success of 2005 and Silver Medal success of 2009. Unfortunately for Australia, the performances of USA and Canada were far improved, with England also making huge progression. A devastating WC ending injury to Jen Adams just prior to the WC was in reflection too large a loss to cover. The benefit of past years of a sizeable NCAA talent pool has decreased in recent years and so has the depth of our talent at the world level. This alone requires us to re-model our preparation program, if we are to keep pace with the rapid development of England, Canada and USA, let alone Wales, Scotland, Japan and other countries throughout Europe.

Australian Men's Team 2014

The team preparation is on track as is the promotion of Newsletters, Supporters Club and recruitment of donations and sponsorship. Sponsorship proposals and naming rights have been targeted to several corporate entities with no commitments as yet. These approaches will continue until the team departs for Denver USA.

Selection camps currently see the squad at 28 as at October 2013, with the final team selected following the tour to Tokyo Japan in February/March 2014.



U19 Australian Women's Team 2015

The program is currently facilitated directly by ALA. Team Personnel appointments are scheduled for November/December 2013. The introduction of Squad Coaches, as the pathway to Assistant Coach positions, is expected to increase the number of coaches while both providing their experience in delivery and gaining the experience of working with HP squads. Applications for the position of Head Coach will be sought from Squad Coaches, with an appointment in July 2014.

Squad member applications are accessed via an on-line facility. State based training and camps will commence in December 2013, with a full squad camp following the Easter U18 Nationals in Melbourne. The U18 Nationals age group presents a difficulty, in that many U19 squad members will be older and not be eligible for U18 Nationals. To overcome this situation, the U19 squad will facilitate competition for those not eligible for U18 Nationals. This same situation will also occur in 2015 and for the U19 men's program in 2015 and 2016. U17/ U18 works for the 4th and 3rd years prior to the world event; U21 works for the 2nd year and year of the world event.

Australian Men's Indoor Team 2015

As determined by ALA in 2013, the viability of this team relies entirely on the National Indoor Championship events being played in 2013 and 2014; and reinforced by viable state association supported domestic competitions. Both these requirements are on track in South Australia, Victoria and New South Wales.

Team Personnel appointments are underway with Head Coach Bob Carter and other positions to follow in the near future. Squad member applications are accessed via an on-line facility. A schedule of training camps will commence shortly following the recent National Championship.

U19 Australian Men's Team 2016

Team Personnel appointments have commenced with Lee Vickery as Head Coach and Ian Webb as Strength & Conditioning Coach. Further appointments are planned in the near future. The introduction of Squad Coaches, as the pathway to Assistant Coach positions, is expected to increase the number of coaches while both providing their experience in delivery and gaining the experience of working with HP squads. It is also expected, with an extended period of preparation before the FIL 2016 U19 Men's World Championship in Coquitlam Canada, squad members and the final team will reach their full potential.

Squad member applications are accessed via an on-line facility. State Based training and camps will commence in February 2014.

Sponsorship

Australian Women's Team Program

Our partnership with Under Armour continues for a second term with a four year agreement secured in January 2013 which will conclude in December 2016. For a fifth consecutive Australian Women's team, Under Armour was our official outfitter, once again provided leading edge apparel and footwear to the 2013 Australian Women's Team for the 2013 World Cup. The 2013 U23 Australian Women's team also purchased their apparel and footwear from Under Armour. Our ongoing partnership with Under Armour provides huge support to ALA and our Australian Women's Team representatives.

Australian Men's Team Program

An equipment and playing uniform sponsorship was secured with Maverik-Cascade by Glenn Meredith having direct contact with them at the NCAA Coaches Convention in January 2013. This is an exciting partnership for ALA and the Australian Men's Team and from this partnership comes the opportunity to gain an ongoing arrangement. We look forward to exploring these prospects.



Officiating Report

The great Australian spirit of volunteering has continued to support our sport. National and International events were well covered by our dedicated group of officials willing to give their time, and usually at their own expense, to make sure our National and International events were well covered.

National Events

Officials attended the ALA Under15 Boys and Girls Tournament in Adelaide, the ALA Under18 Boys and Girls Championships in Perth, the ALA Senior Men's and Women's Championships in Melbourne and the ALA Indoor Championship held in Barmera, SA.

Growth Report

Mike Slattery

The Growth mission of the ALA was to create and drive the implementation of a development program which would result in the capture of actual lacrosse members and participants in Australia. Further it would implement programs that significantly increase those numbers in each season ahead.

With thanks to all Member Associations, capably led by their executives, we have collectively worked hard to identify that we have recorded and reported forty six thousand members and participants for lacrosse in Australia during 2013. The detailed figures are Members of 6,687 and Participants of 39,228 (total = 45,915). This significant number is way in excess of our previous understanding and reporting. It must be acknowledged that this results from full and comprehensive collection of Member statistics matched with innovative and pioneering State development activities for factual Participation statistics. And we do collectively believe that we haven't fully captured all the actual lacrosse activities conducted in Australia – yet (a challenge for future years ahead!). Additionally we look forward to additional growth and development of lacrosse across Australia to add to that now totally identified baseline.

A Growth Advisory Council was formed, framed (via Terms of Reference) and operated over 2013. Its charter originally had 6 projects identified, targeted and staffed. The operational reality and output resulted in 3 projects being fully progressed (Social Media per Kristen Cody/NSWL, Web Based Resources per Kristen Stone/LV, Development and Retention per Luke Oswald/LSA). Those results were significant and will support the development of lacrosse and the support of the (new, soon to be released) ALA website with social media interaction.

A National Framework for Development was created (particular thanks to Glenn Morley/LWA and ALA) which now requires research, best practice identification, local competition enhancements, talent identification, funding, etc). This has been targeted and is endorsed by the States attending the 2013 Growth Forum with activities leading to a full, agreed and innovative implementation during 2016.

Development and participation for sport (hence broadly speaking – Growth) is a key tactic being developed and supported by the ASC. It also is vitally important to the ALA. We must be innovative, while supporting our traditional lacrosse, and increase our numbers in the years ahead. So much over such a wide spectrum depends upon this for the ultimate success of our fine sport of lacrosse.



Coaching Report

Glenn Morley

2013 was a very rewarding year for me personally in the role of Director of Coaching. It saw the realisation of a couple of key projects that will set us up for future years.

Again a majority of my time has been spent looking over previous documents and processes; this has been a valuable experience as we look to merge some of the great work that has been done in the past with contemporary thoughts on coach education.

It is exciting that the planning and research phase has been wrapped up on a lot of the objectives and we will see a lot of action in the coaching portfolio for 2014 and beyond.

Objective: Ensure quality coach education programs for all levels

The club coach course continues to be well received and delivered within the lacrosse community. It has provided a valuable first step in formal coach accreditation and we are looking to build on its effectiveness through the training of presenters in QLA. We are still yet to complete presenter training in NSWL and LTas, but with current presenters we are well placed to service these two key developing member Associations.

As part of the review of the Course we have identified a need to provide Recognition of Prior Learning to many people who the course does not suit due to their previous coaching experience. This process has been completed and will be distributed to all Member Associations shortly to allow us to meet our stated goal and policy of 100% Coach Accreditation by June 2013.

The post course-follow up and the procedures / policies around the accreditation still need to be improved and this will be achieved through the Coaching Operations manual that will detail everybody's role in delivering quality coach education.

To supplement the Club Coach course we are also looking to add a couple of branches to the course to better meet the needs of the various coaches that currently attend the course. These will mainly be regarding the ages of the groups being coached.

The further development of the Advanced Coach Course (Level 2) is underway, although behind schedule to where I would have liked it to have been. This course will be a key to drive continued development as it will meet the needs of many of our more experienced coaches who have been looking for further support and education. The draft module outline has been completed and the course will be inclusive of all the Australian Sports Commissions required General Principles, with breakout modules specific to the men's and women's tactics and skill sets.

In the courses development best practice has been researched from US Lacrosse, the Canadian Lacrosse Association and the AFL to ensure that the course is dynamic and of the highest standard to ensure a sustainable coach education pathway.

Following the completion of the Advanced Coach course we will be addressing the High Performance course and look to determine the best structure to develop and run the course. We are investigating whether this course is best placed with the FIL to embrace an all of sport approach. This course will be aimed at the Elite Australian Head Coaches



Objective: Establish a centralised National Database of registered/accredited coaches

The database has been a slow process however we are seeing some rapid movement that will see a far more effective system in operation. We will be using Sportingpulse to host our coaches' database which will enable us to have a one stop shop for players, coaches and officials. This will lead to greater efficiencies in tracking players and coaches and allow for a more robust system. Each individual will only have one record in the system so if we update someone's details in their playing record it will carry over to any other qualifications they have.

The individual MA's will be responsible for updating the coaches records post course which will lead to greater efficiencies in our post course follow up and finalisation of a coaches accreditation.

To support the MA's full database instructions an in-service will take place and will be included in the ALA Coaching Operations manual that was mentioned earlier.

National Coaching and Officiating Conference

The ALA's inaugural Coaching and Officiating Conference was a great success. Being the first event of its kind for Lacrosse in Australia we were very proud of the product we put forward. The venue and all presenters were fantastic and were exceptionally well headlined by AFL Coaching Ambassador Stan Alves.

It is clear there is an appetite for this type of event and ongoing education for our coaches. Whilst our initial numbers were modest in attendance with a good program delivered first up and greater advanced planning we hope to grow our numbers to 100+ for 2014.

Resources, Information and Website

To complement the registration for the conference we developed some coaching resources to give the attendees a little extra. We developed a coach's diary which was well received and is now available for purchase from the ALA. We hope to expand the diaries and resources section as we revamp the website in the coming months.

For 2014 I am looking to develop a book of drills, aimed at each of the age groups. This will complement the work we are doing on the National Framework and I envisage this will be supplied with the Club Coach Course to further support our new coaches.

With the prevalence of coach information on the internet it will become a focus for us that we can use our website as a link to this information to provide ongoing support to our coaches. This will also be supported by a Coaches newsletter, this was sent once in the lead up to the national conference as a test run, and we look to expand it to a quarterly distribution from 2014.

Long term Strategic Aims

To complement the short term focus of projects in 2013, a review of the Strategic objectives and measurables in the KRA were also undertaken when the ALA Strategic Plan was reviewed.

The most important measurable will be the compulsory accreditation of all coaches by June 2014. This is a big step forward in our commitment to coach education, a result of which must be a quality education pathway developed through the Club, Advanced and High Performance Coaching Courses

Objectives:

- Implement national coaching accreditation and education programs.
- Produce quality and appropriate accreditation programs at Level 2 and Level 3.
- Enhance the consultation of coaches in the review and refinement of the rules of lacrosse.
- Provide pathways and opportunities for development.

Measurables:

- All coaches must be accredited coaches by 30 June 2014.
- Establish a national coaching Advisory Council.
- Coach materials and resources are available to be provided.
- Design and implement an approved Level 2 accreditation course.
- Design and implement an approved Level 3 accreditation course.
- Conduct a national Coaching and Officiating Workshop in early 2014.

Mr. Isaachsen was President of ALC 1962-65, then Vice-President for 14 years until 1979. He was elected as a Fellow of the ALC in 1994. He lived in South Australia and died in 2009, aged 97 years.

The Shelley Maher Trophy for the fairest and best player Australia-wide was won by Jessica Kennedy (Western Australia).



The trophy is named in honour of Shelley Maher and was instituted in 2012 by the ALA. As the last President of Women's Lacrosse Australia (2001-2009) Shelley committed to excellence in all areas of administration. In her home State of Victoria Shelley was President of Women's Lacrosse Victoria (1998-2001), and was elected a Life Member in 2001, and in 2009 of Women's Lacrosse Australia. She was active as a player with Williamstown Women's Lacrosse Club and represented Victoria in senior competition (2002, 2005). Shelley was an ALA Director (2007-2010) and now resides in the USA where she remains active in lacrosse as the Women's Director on the Federation of International Lacrosse.

Congratulations are extended to Thomas and Jessica on achieving the pinnacle fairest and best player award in Australia.

Coaching

With the Director of Coaching position vacant for most of the year, Coaching development activities have been limited. The appointment of experienced coach Stacey Appleton to this role late in the year will enable the Board to focus more pro-actively on Coaching Development and Accreditation in 2014.

We pay tribute to and thank our many volunteer Coaches at Club and Association level.

Development

Development highlights from 2013 include:

High School Competition

This competition featured junior (Years 7-9) and senior (Years 10-12) divisions for both girls and boys, playing 6-a-side on a smaller sized field. The competition had 125 participants (61 boys and 64 girls), with 6 teams from 3 schools in 2 divisions of the boys' competition, and 7 teams from 7 schools in 2 divisions of the girls' competition.



Pleasingly the High School Competition is bringing new players into the sport, from both the boys' and girls' competitions.

University Competitions

The SA Challenge competition between the three SA universities featured lacrosse for the third time on 15 July this year. There were four teams with each university represented, and Adelaide Uni entering two teams.

In addition to the SA Challenge, a national intervarsity 5-a-side tournament was held in October, to coincide with the traditional Intervarsity (field lacrosse) matches between Adelaide and Melbourne University Lacrosse Clubs. The three SA universities entered, as well as Melbourne Uni and a combined NSW universities team. The team from New South Wales took out the inaugural trophy.

The ultimate aim is for lacrosse to be included in the Australian University Games, which will significantly raise the profile of the sport and growth the game across the country, both in established and developing lacrosse centres.

"Comets" – IGSSA Representative Team at ALA Under 15 Nationals

The highlight for the development portfolio this year was the formation of the IGSSA (Independent Girls Secondary Schools Association) representative team – the "Comets", who debuted in this year's ALA Under 15 Nationals, and won every match to win the tournament!

The rationale for creating the team was to provide IGSSA with the opportunity to field a representative sports team to compete at a major tournament – something not offered by other sports in IGSSA's programme. By doing this we hope to raise the profile of lacrosse among IGSSA schools, and give more weight to the case for adding lacrosse to IGSSA's sports programme.

Independent Schools Junior Girls' Sports Group (ISJGSG)

During 2013 we met with representatives from the ISJGSG with a proposal to conduct a lacrosse competition for member schools. ISJGSG is a school sports association for primary school girls up to Year 6, and consists of 15 schools. It was resolved that Lacrosse SA will run a lacrosse competition for ISJGSG for girls in Years 4-6 in 2014 Term 4.

Primary School Development

Our annual LSA SAPSASA event early in the year saw XX students in 68 teams from 13 schools participating.

At ACHPER (Australian Council for Health Physical Education & Recreation) PE Week we showcased our sport to 10 plus schools. It's a great avenue for forming relationships with PE teachers with a view to running school lacrosse clinics.

At the Tea Tree Gully SAPSASA sporting carnival we ran lacrosse clinics for 600 kids from 14 schools.

Events

Japanese Lacrosse Camps

Once again, in conjunction with Bunnik Travel and Trish Adams from Velocity Lacrosse we ran camps for visiting groups from Japan during March.

Mad March Lax Fest

This event was held at Yankallila on the Fleurieu Peninsula and incorporated a Golf Day and a two day lacrosse event in which 138 players, including a large Japanese contingent participated. As well as being a pre-season hit out, the event raised funds to support the State Men's and Women's State teams and was organised by Tim Dickson under the LaxRatz Australia banner.



ALA Under 15 Boy's and Girl's Tournament

This was a particularly big event this year (8 Girl's teams, 7 Boy's teams) held at LSA Headquarters – Barratt Reserve at Adelaide Shores. It's becoming increasingly difficult for an individual Club to run these events, and again this event was run by a volunteer LSA group, with assistance from Staff. At the time of writing we are about to survey participants for their feedback.

Australian Club Championship

This event was moved from its traditional time slot of the June long weekend due to the scheduling of the National Championships, and was played in October immediately following the Under 15 National Tournament with the Premiership Teams from 2012 plus a wild card being invited to participate. In the end only Brighton (SA) and Newport (Victoria) participated in the Women's event – won by Brighton, while the last minute withdrawal of Williamstown (Vic) saw Brighton and Glenelg (SA) and Wembley and Bayswater (WA) participating in the Men's event – won by Bayswater. Thank you to Graham Hobbs and the Eureka Group for his generous sponsorship of this event.

National Indoor Box Championship

Held in November at Barmera in the Riverland. Teams from SA, Victoria and a combined SA/NSW team competed, with Victoria defeating SA in the Grand Final.

Officiating

We have been without a Director of Officiating for most of the year, so apart from the activities organised by ALRA (SA) and SAWLUA the Officiating Committee has not been active.

Other Highlights

Governance Structure

2013 was the first year of a revised Governance Structure which saw the experimental formation of a smaller Board to concentrate on strategic matters, and the clearer definition of the Terms of Reference for the various committees to give them more autonomy for operational matters in their sphere of responsibility. Its efficacy is still the subject of debate, but it has been decided (subject to the approval of the LSA AGM) to continue with the structure in 2014.

Junior Teams

Pleased to report:

- An extra team in our U13 Girl's competition in 2013, and the continuation of two divisions featuring a number of College teams
- An extra team in U15 Girl's competition. We reverted to a single division but this will be reviewed in 2014
- For the first time in many years all "mainstream" clubs had a team in the U13 Boy's competition.
- Despite some initial difficulties we were able to maintain an U17 Boy's competition.
- An unprecedented four teams competing in the ALA Under 15 Girl's and Boy's Tournament

360° Review

Along with most funded sports in SA we participated in a 360° review conducted by the Office for Recreation and Sport. The resultant report will form the basis of an action plan for 2014.



Women's Rules

As an experiment this year, the LSA Women's State League rule variations were used in Divisions 1, 2 and Under 18 girls. The continuation of this in 2014 is currently under review.

Volunteer Recognition

Coaching

A club coaching course was held early in the year with 19 attending, made of association Development Officers and local junior coaches.

Two local coaches were sent to ALA National Conference with the requirement to deliver information and education to WA members on return. This program is not complete yet, but will be by the beginning of season 2014.

Development

Lacrosse WA, supported by Healthway and the Smarter than Smoking message, continued its program of delivering modcrosse to schools and community groups in the metropolitan area and to selected regional areas. During the end of 2012 and through 2013 to date Development Officers have presented approximately 810 modcrosse sessions in 78 primary schools and 16 secondary schools in Western Australia. In July 2013 we received approval of (increased) funding for a further 18 months, which will take us to the end of 2014. LWA also assisted in numerous lightning carnivals in the metropolitan area and again presented at teacher in-service days and Edith Cowan University PE teacher training.

Events

Bayswater Lacrosse Club hosted the Under18 National Championship at the beginning of the season in April. The outstanding facilities and volunteers at Bayswater ensured that this event met, and in fact surpassed the usual standard of this national championship. With lighting suitable for night matches, games could be scheduled later in the day, which was helpful in avoiding the heat of the day, and in allowing more members and interested people to view the games outside of working hours. New Zealand participating in the women's tournament was a welcome breath of fresh air that added intensity to the games and provided a great relationship building opportunity between our countries.

Joint end of season finals and functions met with some challenges with regard to weather, but in the end, both were fabulous opportunities to see and acknowledged great local lacrosse achievements.



Officiating

Women's accreditation rates increased at the lowest levels, four umpires awarded State accreditation and two promoted to national accreditation.

It was particularly pleasing to have three WA members officiating at the 2013 FIL Women's World Cup and a fourth member at the ASPACS.

Current accreditation is 36 beginners, 5 state, 3 national & 2 international.

We were pleased to welcome back our long term employee, Ellen Kennedy in July, after an absence due to a long term illness,

Clubs are, right now, in the process of gathering together a group of people, with a specific interest in finding innovative promotional opportunities and programs for lacrosse throughout the state. Working together for the common good of lacrosse will be the outcome, and it is from this encouraging base that we look ahead to 2014 with a view of lacrosse being not just, different but BETTER.

Coaching

There has been minimal strategic emphasis on coaching development over the past 12 months. Lacrosse Victoria (LV) recognise this to be an area requiring significant attention and would ideally like to move to having all Coaches accredited by 2014. Whilst there is a National Coaching accreditation program in place, the pathway is not clearly articulated on either the LV website or Australian Lacrosse Association (ALA) Website, importantly these issues are being addressed. LV is committed to establish Coaching accreditation in line with National Accreditation.

Over the past 12 months LV has conducted teacher workshops to over 530 participants, (one of these workshops was conducted in Warrnambool) and delivered four level 1 Coaching Courses.

In November LV will be presenting at the 2013 ACHPER Conference, which is the premier professional learning event for teachers and industry professionals in Health, Physical Education, Sport, Recreation and related fields.

- Delivered Teacher Workshop to 7 Universities – 500+ Student Teachers
- Level 1 Coaching Course dates set for 2013 – 2014 from feedback given by Clubs

Development

Development has been a strong focus area for LV in 2013. In 2012 LV was successful in receiving a funding grant (Victorian's More Active) through Sport Rec' Victoria, Victorian Government, this has enabled LV lead a number of initiatives to grow the game of lacrosse, these include:

1. Developing Lacrosse as a preferred school sport in Private Girls Colleges' across Melbourne through the establishment of the Girls Sport Victoria (GSV) program. This has been run as a LV Project, with coaches recruited from clubs to run 45 school clinics at 9 schools for 750 girls. This will culminate in a school competition between schools interested in trying their skills against other schools in the GSV system. With the aim for Lacrosse to become a chosen sport in the GSV Program, a number of schools have held teacher resource training, and will be able to run their own lacrosse programs in the future. Already the Associated Catholic Girls Sports have requested a date in 2014 to hold a school finals day. GSV Primary schools have also expressed interest in holding clinics in term 1 of 2014, the word is spreading.
2. The Southern Indoor Lacrosse League (SILL) has been created by 4 clubs who have combined to start up an indoor development competition to recruit new junior and senior people into the sport. It will be an 8 week season up until Christmas and an 8 week season at the beginning of the 2014 with 12 teams planned for the competition. The aim is to further support the development of similar competitions by other clubs.
3. Victorian Box Lacrosse League (VBLL) has started its second season with a 4 team competition and a junior training session preceding the senior competition. As with last season, a draft system has been held to create an even development competition, this has resulted in a hard and close competition, improving the skills of the players new to the game. The annual Australian Indoor Championships (held at Barmera, in the North East Region of South Australia) saw Victoria win the National title for the second consecutive year.
4. Development of a teacher coaching plan to be implemented through PE Departments
5. Focus on increasing the number of umpires and official in Women's Lacrosse
6. Development of multi-tiered levels of LV membership and a LV Membership card is well under way and will have provision for players, past player association, officials, coaches, volunteers, parents and country members, which will also aid accurate data collection of the sport.

The above initiatives have been actioned as part of our funding agreements with the State Government bodies.



Importantly a major achievement for LV in 2013 was the re-establishment of the Junior Development Committee. The task of the committee is to review the systems and processes that enable member clubs and LV to increase junior participation and membership.

Other highlights for 2013 in development include:

- Successful inaugural trip to University of Ballarat with 31 fourth year student Teachers trained
- Record numbers for Year 7 and 8 School Competition with 15 teams entered, 5 of 8 schools are entering a team for the first time, 12 girls teams entered.
- Development trip to Warrnambool undertaken - 27 student Teachers trained

Events

A strategic initiative of LV for 2013 was to hold the Men's and Women's Grand Final on the same day at an enclosed seated venue. This was a significant venture for the Board to undertake requiring a substantial booking fee, this would also mean that spectators would be required to pay to get in and given the history of lacrosse being played in open public spaces would serve as a good test of people's willingness to pay to watch lacrosse.

In total, there were 982 paid attendees, under 15's were free of charge, it is estimated that between 1200 and 1300 attended on the day. Given the success of the event, LV is committed to hosting future Grand Finals at premier facilities.

In June, LV held the Senior Men's and Women's State Championships in conjunction with the Down Under Cup, the event was hosted by the Footscray Lacrosse Club.

June 5 – 8, Japan competed in the Men's State competition along with Victoria, South Australia and West Australia and New Zealand competed in the Women's along with the other states.

The Down Under Cup, June 7 – 9, attracted 2 teams from the U.S, 2 teams from Japan and the Australia Under 23's in the Men's competition and New Zealand competed against the Under 23 Australia team in the Women's Competition.

Officiating

In 2013 LV made significant progress in the area of officiating, this largely due to the acknowledge need by all stakeholders that as a sport we need to increase referee and umpire recruitment and present officiating as a desirable participation avenue. Key achievements throughout the year were:

- The development/implementation of Women's Club Umpiring course and mentoring program for Umpires (three women were trained as mentors, with one umpire mentored).
- Technical committee established in consultation with ALRA Victoria Branch and Women's Officiating Council of Victoria.

Other Highlights

Appointment of General Manager

In July Rod Kimmitt was appointed the inaugural General Manager of Lacrosse Victoria. His key role is to drive the growth and sustainability of Lacrosse in Victoria, primarily through the implementation of the LV Strategic Plan 2013-17. Rod will be a great asset to Lacrosse with his previous experience in Sports Administration.

Communications Plan

A key achievement for 2013 was the development and implementation of the LV communications plan. The LV Communication Sub Committee has been tasked with overseeing the roll out and evaluation of this plan. In addition the committee is currently in the process of developing a Digital



Communications Strategy, to run in conjunction with the LV Communications Plan, for implementation in 2014.

Evaluation of increasing women and girls participation

In 2011 Lacrosse Victoria received a SSAPP grant from VicHealth to increase the participation and membership of women and girls in Lacrosse. In 2012 Lacrosse Victoria commissioned Dr Lucio Naccarella, PhD from The Australian Health Workforce Institute at The University of Melbourne to evaluate what Lacrosse Victoria strategies work for whom and in what circumstances. The evaluation also sought to build the capacity of Lacrosse Victoria to use evaluative evidence to increase the participation and membership of women and girls in Lacrosse in Victoria. This evaluation was completed in early 2013.

In closing, LV acknowledges the hard work and major progress ALA is taking to grow the sport of Lacrosse. ALA is to be applauded for the work they have undertaken in 2013 and we look forward to working with the National body in 2014.

Coaching

- Brendan Lower accredited as presenter / assessor. Coaching course held in June.
- Club Coaching Course held in June – 6 participants. There are now 10 accredited coaches in total within the Association.

Development

There have been an increased number of schools engaged in the Gold Coast and the Sunshine Coast areas ranging from primary to secondary schools. There is a total of one primary and four secondary schools on the Gold Coast and three secondary schools on the Sunshine Coast. The QLA schools program had over 300 participants in 2013. An inter-university residential college challenge was held in Toowoomba in June with over 150 participants.

Events

The Annual QLA Championships were again conducted with the competition being held at the home grounds of Brisbane Eagles Lacrosse. Two men's teams and two combined women's and junior teams took part.

The state league competition has improved for all players through an increase in competition games from monthly to fortnightly aimed at giving more value for the players. Games continued to be rotated around venues from Gold Coast to Brisbane to Sunshine Coast.

Officiating

A women's lacrosse officiating course conducted in April with 6 new club women's lacrosse officials. QLA received funding under the 'Women in Sport' program to upskill and provide leadership opportunities for three (3) female members of QLA. This Program is being rolled out in the next twelve months with assistance from ALA Director of officiating and Lacrosse Victoria. Participants will be mentored through weekend officiating programs held during the 2014 season in Victoria.

Other Highlights

There is a continued increase in playing numbers in Queensland due to an increased and improved structure, and volunteers, within affiliated clubs.

A major priority for QLA and the affiliated associations/clubs is to drive the growth of junior and female participation within the sport and this will be achieved through the creation of strategic plans for each affiliated association/club which will link to the key result areas of the QLA 2014 – 2016 strategic plan.

Structured competition: A structured competition operating each fortnight which was established following on from the previous season of monthly games. Representation from all four affiliated associations/clubs has helped drive this increase in structured competition featuring accredited officials conducting games, accredited coaches with competing teams and improved presentation of competition games for spectators.

QLA men's representative team travelled to NSW to play in the East Coast Cup.

NOTES TO THE FINANCIAL STATEMENTS

Note 1: Statement of Significant Accounting Policies

The financial statements cover Australian Lacrosse Association Ltd as an individual entity. The Company is limited by guarantee, incorporated and domiciled in Australia.

Financial Reporting Framework

The entity is not a reporting entity because there are unlikely to be users of the financial report who are unable to command the preparation of reports tailored so as to satisfy specifically all of their information needs. Accordingly, a special purpose financial report has been prepared.

Basis of Preparation

The financial report has been prepared in accordance with the requirements of recognition and measurement aspects of all applicable Australian Accounting Standards adopted by the Australian Accounting Standards Board.

Basis of Measurement

The financial report has been prepared on an accruals basis and is based on historic costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

Functional and Presentation Currency

These financial statements are presented in Australian dollars, which is the entity's functional currency.

Use of Estimates and Judgement

The preparation of financial statements requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Actual results may differ from these estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised and in any future periods affected.

NOTES TO THE FINANCIAL STATEMENTS

Note 1: Statement of Significant Accounting Policies (cont'd)

b. Revenue

Revenue is recognised when the Company is legally entitled to the income and the amount can be quantified with reasonable accuracy. Revenue is recognised net of the amounts of goods and services tax (GST) payable to the Australian Taxation Office.

The Company's revenue includes grants received from the Australian Sports Commission and membership fees.

Grants received on the condition that specified services are delivered, or conditions are fulfilled, are considered reciprocal. Such grants are initially recognised as a liability and revenue is recognised as services are performed or conditions fulfilled. Revenue from non-reciprocal grants is recognised when received.

Membership fees are recognised upon the delivery of the service to the members.

Donations and sponsorships are recognised when received.

Interest revenue is recognised on an effective rate basis taking into account the interest rates applicable to the financial assets.

All revenue is stated net of the amount of goods and services tax (GST).

c. Income Tax

The entity has received an endorsement from the ATO confirming that it is exempt from income tax.

d. Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the taxation authority. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the balance sheet.

Cash flows are presented in the cash flow statement on a gross basis, except for the GST components of investing and financing activities, which are disclosed as operating cash flows.

e. Payables

Accounts payable are recognised when the entity becomes obliged to make future payments resulting from the purchase of goods and services.

f. New standards and interpretations not yet adopted

In the year ended 30 June 2013, the Company has reviewed all of the new and revised Standards and Interpretations issued by the AASB that are relevant to its operations and effective for the current annual reporting period .

It has been determined by the Company that there is no impact, material or otherwise, of the new and revised Standards and Interpretations on its business and, therefore, no change is necessary to Company accounting policies.

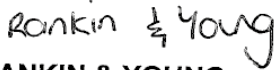
