Dear Mr. or Mrs. President, Dear Mr. or Mrs. Secretary General, Dear Friends.

The 2014 ISSF General Assembly and elections are completed and it is time for the ISSF to work on many high priority issues. We received many comments about our present Constitution, which was approved 35 years ago at a time when the ISSF was smaller and less active. The Constitution needs to be modernized so this is a high priority issue for the ISSF.

After some discussion we have decided that Mr. Vladimir Lisin, newly elected ISSF Vice President, is designated to coordinate a complete review of the ISSF Constitution and prepare proposals for a revised ISSF Constitution.

Vice President Lisin is well qualified to lead this long overdue review of our ISSF Constitution. He is the President of our largest Continental Confederation, the European Shooting Confederation (ESC), and his leadership of the ESC included the development of a modern ESC Constitution. He has already discussed several excellent ideas for change with us so we know he will propose good solutions.

Vice President Lisin's responsibility is to evaluate the present ISSF Constitution and determine what changes are necessary to make it a modern document to more effectively govern the ISSF and support its primary goal of continuing as a major Olympic sport. The ISSF expects to create an Ad Hoc Committee that includes other members of the ISSF Executive Committee and Council as well as the ISSF Statutes and Eligibility Committee to work with Mr. Lisin in this review.

As part of this review, the ISSF is already inviting all Member Federations, members of the Executive Committee, the Administrative Council, the Section Committees and all interested persons who wish to provide comments about the present ISSF Constitution or submit ideas for change to forward them to the ISSF Headquarters to doris@issf-sports.org. We are committed to making this an open, transparent process and want to include in it the whole shooting family. All recommendations received by the ISSF Headquarters will be forwarded to Vice President Lisin for consideration in his Constitutional review and will be discussed by the Ad Hoc Committee.

Vice President Lisin will move quickly to initiate this review and begin formulating proposals for change. After they are finalized, they will be discussed with President Vazquez and will be presented to the ISSF Member Federations, to the Executive Committee and to the Administrative Council so those bodies can support recommendations to the General Assembly. Final approval by the General Assembly requires a two-thirds majority vote.

We kindly ask you to support the creation of a new Constitution and are waiting for hopefully numerous proposals.
