I agree to (i) abide by all lawful traffic directions of NSW Maritime Boating Service Officers and (ii) report all incidents involving a fatality, serious injury and/or damage (where such is considered significant having regard to the types of vessels involved) at the first reasonable opportunity and, in any case within 48 hours of occurrence, to the Race Committee of the RAN Sailing Association and to NSW Maritime irrespective of whether a valid Protest is lodged in relation to any such incident.
