Presidents report (Alister Danks)

- Thanks to current committee members for their contributions. James Scott, Deanne Telford, Chris Batty, Stephen Cowell, Mark Grimshaw, Sophie Burgess, Chris Schey, Bruce Harrop.
- National association set up has been agreed in Jan 2017. Final docs to be submitted to Consumer Affairs Victoria. Will align with reorganisation of Australia Sailing.
- Partner class agreement signed with Australia Sailing. Benefit is a bigger pool of kids into VST. Committed to doing development days for class. Trying to encourage smaller clubs who have minnows. Started that this year and will continue to do this more.
- Great to see lots of clubs represented at our regattas.
- Code of conduct was developed and implemented.
- Boat building. Program has been going for 3 years. Striving for standardisation and making it easier to get replacement parts. Now 22 fiberglass boats and 5 wooden boats built around the Griffin shape. Published a rigging guide.
- Now have a national database of sail numbers. Have a national way for issuing measurement certificates.
- MSA Dropbox, online accounting, persistent email addresses have been set up.

Treasurer report (James Scott)

- Refer attached Income Statement for 1 Mar 31 Dec 2016.
- Financial year corrected from end of Feb to end of Dec, this is why the accounts presented this year are for 10 months only.
- Overall surplus.
- Small surplus for boat building program. Investment in inventory the reason why expenses are up.
- Sold the Minnow trailer and bought a gazebo.
- Income for nationals in accounts but expenditure not there due to timing.
