

# AREA AGREEMENTS AND THE PERMIT SYSTEM

# 1. PERMITS

There are a number of ways in which a player can participate with another club without being transferred (cleared) to that club. These are all covered under VCFL Regulation 2.0.

- VCFL Permit: A player can play up to eight games with a major league club but these games can only be with the senior grade competition, neither reserves nor underage. (refer to VCFL regulations 2.1 2.8)
- **VCFL Student permits:** A student living away from home and returning to the club with which he was last registered (prior to being transferred to his current club) during registered school holidays or semester breaks may apply for a permit to play with this club. (refer to VCFL regulation 2.11)
- Area Agreement permits: These are the most common permits and a player can apply for a permit only if his current league and the league in which he wishes to compete have developed an area agreement that allows this to occur. (refer to VCFL regulation 2.10 and the information following)
- Day Permit from the opposition on the day: If an underage team is short of players on any particular day, then the HDFL allows players from the opposing team play for the opposition on a day permit (see appendix 10). Please note that these players should be removed from their current club's team list and then applied for on line in the same manner as any other permit player. Also, these players should NOT play half a game for the opposition then change with another player and play the other half for their team. They must play the entire game with one team or the other. (refer to VCFL regulation 2.9)

**NOTE:** For the purpose of numbers on the team lists, these opposition permit players do not count as players from another league and therefore do not necessarily limit the team list to 20 players (unless permit players are also used from another league on the same day)

**NOTE:** Permits may be applied for at any time during the season. They are **not** subject to the June 30<sup>th</sup> cut off day that applies to transfers (clearances)

# 2. AREA AGREEMENTS

The Heathcote & District Football League (HDFL) has negotiated area agreements with a number of surrounding leagues in accordance with VCFL regulation 2.10.

For the current season these leagues include:

- Bendigo Football Netball League (BFNL)
- Bendigo Junior Football League (BJFL)
- Loddon Valley Football League (LVFL)
- Goulburn Valley Football League (GVFL)
- Goulburn Campaspe Junior Football League (GCJFL)
- North Central Football League (NCFL)
- Shepparton and Districts Junior Football League (S&DJFL)
- Seymour District Junior Football League (SDJFL)

These area agreements can be found in appendices 1 through 8.

#### PURPOSE:

In general, area agreements have been developed to provide the capacity for a club to field an underage team on the day of competition with the aim to have that team being competitive during the match. They have <u>NOT</u> been developed to provide an opportunity for a player to play at a higher level, to gain experience or to "try out" at that higher level at the expense of a currently registered player.

#### **CONDITIONS:**

In general, the following conditions apply:

- All available club registered players must be listed on the team sheet before any permit players can be considered.
- There is a limit on the number of permit players allowed for each game. (Usually 6)
- There is a limit on the maximum number of players that can be listed on a team sheet, including any permit players. (Usually 20)
- <u>Some</u> area agreements place a limit on the number of permits that a player may apply for during any one season. (Usually 8)

An area agreement is specific to the leagues involved and it is incumbent on all clubs to be aware of the conditions governing the use of permits under each area agreement.

# 3. OBTAINING A PLAYER ON A PERMIT.

All requests for a player on a permit must be applied for on line through the Sportzware system on the members' database.

However, prior to applying on line, the appropriate paper work must be completed. You can only apply for a permit player if we have an area agreement with that player's current league or if he falls under the VCFL permit system.

# Paper work required:

A match day permit form must be completed by all relevant people. This form must be signed by all parties which includes the player, a parent or guardian of the player (if he is under 18), a representative of the player's current club and a representative of the club requesting the permit.

THE PLAYER'S NAME and DATE OF BIRTH MUST be written legibly in the appropriate place on the form.

A copy of this form must be forwarded to Central Victoria Football, usually via facsimile (5441 1295) or with the match day documents

A copy of a match day permit form is shown in Appendix 9.

Once this form has been completed ONCE, then the club may apply for the player on line whenever he is able to participate as a permit player. Without this form, the player <u>MUST NOT</u> be requested on line.

Requesting the player as a permit player:

- Enter your club's member database and click on the "Request a Transfer/Permit".
- Search the system using the bottom option by entering the player's name and date of birth (hence the requirement to have these written legibly on the permit form)
- Click "Select" button: this should give the player's current details.
- After checking that you have the correct player, click on "select".
- Scroll down passed the "Submit Transfer" button.
- From the drop down "Permit Type" menu select "1. Match Day"
- Enter the date in which you wish the player to participate. The "From" date and the "To" date should be the same.
- Click on the "Submit Permit" button.

#### No further action is required

The player is now available to be selected onto your team sheet for that particular date. When the team sheet is printed out, he should be indicated with a (P) beside his name.

There is no need to submit a new permit form each time you require this player once the form has been submitted. Even if you complete and submit the form but do not use the player until later on in the season, you do not need to complete a new form. Just apply on line in the manner above each time the player is required BUT making sure that he is available to play.

#### 4. WHAT ARE THE OTHER PERMITS FOR?

In applying online, you may have noticed that there are two other permit types available:

- 2. Local interchange
- 3. Temporary Transfer

<u>Local interchange</u> is used when a player is on interchange with another club in another league for an extended period of time.

For example, a player with your club has been selected in the Bendigo Pioneers squad. The Bendigo Pioneers will apply for a local interchange for the entire season. He will NOT be transferred from your club to the Pioneers. However, this player will be able to be selected on your team sheet if he is not required for the pioneers on any on weekend without the need to be transferred back again. This process is not an automatic approval but will need each club and league to approve the permit on line. (A match day permit is automatically approved once the application on line has been processed)

<u>Temporary Transfer</u> is mainly used for a player transferring to a club in the Northern Territory competition (and vice versa) during the off-season. This type of transfer also requires on line approval by all clubs and leagues.

# 5. WHAT ABOUT JUNIOR PLAYERS FROM OUR CLUB PLAYING IN A DIFFERENT LEAGUE TO OUR SENIOR PLAYERS?

If you have the situation where your senior and junior clubs belong to the one incorporated body, then players who are under 16 ½ years of age do not need to apply for a permit to play for their senior club.

If the junior club plays in a different league to the senior club, then to ensure that players are available for selection on either team sheet, you must apply on line for a **Local Interchange** permit. This is done in the same manner as a Match Day permit outlined above, but the "from" date is usually the start of the season and the "To" date should be just after the end of the season. Remember this must be approved online by all parties before the player can be used for either junior or senior clubs. (For the purpose of this information, the senior club includes the under 17 team as well as seniors and reserves)

<u>NOTE:</u> For the purpose of numbers on the team lists, these local interchange permit players from your junior club, do <u>not</u> count as players from another league and therefore do not necessarily limit the team list to 20 players (unless permit players are also used from another league on the same day)

#### **APPENDIX 1:**

# AREA AGREEMENT between HDFL and BENDIGO FNL (BFNL)

#### 1.0 AREA AGREEMENT:

This agreement has been signed pursuant to the Victorian Country Football League Incorporated (VCFL) Rules and Regulations pertaining to clearances and permits and in particular clause 2.10 whereby an interchange of players between Clubs of the above-mentioned Leagues may take place without clearance and is subject to any provisions contained within this agreement.

#### 2.0. SPECIAL CONDITIONS:

- a) That all available Club registered players are selected before permit players can receive an endorsement to play
- **b**) That this Agreement is in force for the current season only with the agreement to be signed at the start of the year. Copies to be held by each League and club secretary.
- c) That the players involved desire to play with the club in the other League on the day in question.
- **d**) That the Clubs involved are agreeable to the players playing on the day in question.
- e) That the players concerned are acquainted with VCFL Regulation 2.0 regarding permits.
- **f**) That prior to playing their first game under this agreement, the player shall obtain permission to do so from his parent Club using the permit form provided with this agreement.
- **g**) Players of any club having a bye (including a split round) will be allowed to play with a club in the other league on that day.

# 3. NUMBER OF PERMITS NOT SPECIFIED

- a) A BFNL player may be granted area permits by their club to play in the HDFL during the HDFL home and away season, provided that they meet any age requirement of the HDFL.
   Day permits can be issued if there are no more than 20 players listed (including permit players) on their relevant team sheet. Players may play TWO games per weekend but only ONE per day
- b) An HDFL player may be granted area permits by their club to play in the BFNL during the BFNL home and away season, provided that they meet any age requirement of the BFNL.
   Day permits can be issued if there are no more than 20 players listed (including permit players) on their relevant team sheet. Players may play TWO games per weekend but only ONE per day
- c) All teams are only permitted to play a maximum of SIX permit players in any one match.

# 4. TRANSFERS

Transfers of players between the above-mentioned Leagues shall close on the 1st day of July of the current season

# 5. REPORTED PLAYERS

A player playing on permit who is reported shall face the Tribunal of the League in which the offence was committed.

Any penalty that is imposed shall apply in all competitions.

# 6. FINALS PERMITS.

**No** match day permits are to be issued for players to play in any grade of the Final series of either league.

#### **APPENDIX 2:**

# AREA AGREEMENT between HDFL and BENDIGO JUNIOR FL (BJFL)

#### 1.0 AREA AGREEMENT:

This agreement has been signed pursuant to the Victorian Country Football League Incorporated (VCFL) Rules and Regulations pertaining to clearances and permits and in particular clause 2.10 whereby an interchange of players between Clubs of the above-mentioned Leagues may take place without clearance and is subject to any provisions contained within this agreement.

#### 2.0. SPECIAL CONDITIONS:

- a) That all available Club registered players are selected before permit players can receive an endorsement to play
- **b)** That this Agreement is in force for the current season only with the agreement to be signed at the start of the year. Copies to be held by each League and club secretary.
- c) That the players involved desire to play with the club in the other League on the day in question.
- **d**) That the Clubs involved are agreeable to the players playing on the day in question.
- e) That the players concerned are acquainted with VCFL Regulation 2.0 regarding permits.
- **f**) That prior to playing their first game under this agreement, the player shall obtain permission to do so from his parent Club using the permit form provided with this agreement.
- **g**) Players of any club having a bye (including a split round) will be allowed to play with a club in the other league on that day.

# 3. NUMBER OF PERMITS NOT SPECIFIED

- a) BJFL Players may be granted by their clubs day permits to play in the HDFL during the HDFL home and away season provided they meet any age requirements in the HDFL.
   Day permits can be issued if there are no more than 20 players listed (including permit players) on their team sheet. Players may play TWO games per weekend but only ONE per day
- b) HDFL Players may be granted by their clubs day permits to play in the BJFL during the BJFL home and away season, provided that they meet any age requirement of the BJFL.
   Day permits can be issued if there are no more than 20 players listed (including permit players) on their team sheet. Players may play TWO games per weekend but only ONE per day.
- c) All teams are only permitted to play a maximum of SIX permit players in any one match.

# 4. TRANSFERS

Transfers of players between the above-mentioned Leagues shall close on the 1st day of July of the current season

# 5. REPORTED PLAYERS

A player playing on permit who is reported shall face the Tribunal of the League in which the offence was committed.

Any penalty that is imposed shall apply in all competitions.

# 6. FINALS PERMITS.

**No** match day permits are to be issued for players to play in any grade of the Final series of either league.

#### **APPENDIX 3:**

# AREA AGREEMENT between HDFL and LODDON VALLEY FL (LVFL)

#### 1.0 AREA AGREEMENT:

This agreement has been signed pursuant to the Victorian Country Football League Incorporated (VCFL) Rules and Regulations pertaining to clearances and permits and in particular clause 2.10 whereby an interchange of players between Clubs of the above-mentioned Leagues may take place without clearance and is subject to any provisions contained within this agreement.

#### 2.0. SPECIAL CONDITIONS:

- a) That all available Club registered players are selected before permit players can receive an endorsement to play
- **b)** That this Agreement is in force for the current season only with the agreement to be signed at the start of the year. Copies to be held by each League and club secretary.
- c) That the players involved desire to play with the club in the other League on the day in question.
- d) That the Clubs involved are agreeable to the players playing on the day in question.
- e) That the players concerned are acquainted with VCFL Regulation 2.0 regarding permits.
- **f**) That prior to playing their first game under this agreement, the player shall obtain permission to do so from his parent Club using the permit form provided with this agreement.
- **g**) Players of any club having a bye (including a split round) will be allowed to play with a club in the other league on that day.

# 3. NUMBER OF PERMITS NOT SPECIFIED

- a) A LVFL player may be granted area permits by their club to play in the HDFL during the HDFL home and away season, provided that they meet any age requirement of the HDFL.
   Day permits can be issued if there are no more than 20 players listed (including permit players) on their relevant team sheet. Players may play TWO games per weekend but only ONE per day
- b) A HDFL player may be granted area permits by their club to play in the LVFL during the LVFL home and away season, provided that they meet any age requirement of the LVFL.
   Day permits can be issued if there are no more than 20 players listed (including permit players) on their relevant team sheet. Players may play TWO games per weekend but only ONE per day
- c) All teams are only permitted to play a maximum of SIX permit players in any one match.

# 4. TRANSFERS

Transfers of players between the above-mentioned Leagues shall close on the 1st day of July of the current season

#### 5. REPORTED PLAYERS

A player playing on permit who is reported shall face the Tribunal of the League of which the offence was committed.

Any penalty that is imposed shall apply in all competitions.

# 6. FINALS PERMITS.

**No** match day permits are to be issued for players to play in any grade of the Final series of either league.

#### **APPENDIX 4:**

# AREA AGREEMENT between HDFL and Goulburn Valley FL (GVFL)

This agreement is signed pursuant to the Victorian Country Football League Incorporated Rules and Regulations pertaining to clearances and permits and in particular clause 2.10 whereby an interchange of players between Clubs of the above-mentioned Leagues may take place without clearance and is subject to any provisions contained within this agreement.

# PROVIDED HOWEVER

- That this Agreement is in force for the current season only with the agreement to be signed at the start of the year. Copies to be held by each League and club secretary.
- That the players involved desire to play with the club in the other League on the day in question.
- That the Clubs involved are agreeable to the players playing on the day in question.
- That the players concerned are acquainted with V.C.F.L. Regulation 2.0 regarding permits.
- That all relevant persons complete a current permit form, and that this form is submitted to the league administration prior to the player playing their first permit game. Failure to do so may result in a penalty as deemed appropriate by league administration.

# **NUMBER OF PERMITS**

- Two area permits may be granted for a HDFL player to play with a GVFL reserve grade team during the current season.
- Two area permits may be granted for a GVFL player to play with a HDFL reserve grade team during the current season provided the player is excess to the GVFL club needs and has he NOT played a GVFL senior grade game in the current or preceding season.
- Four area permits may be granted for a HDFL player to play with a GVFL under 18 team provided they are within the age group of the GVFL competition during the current season.
- Four area permits may be granted for a GVFL player to play with a HDFL under 17 team provided they are within the age group of the HDFL competition during the current season. All available registered HDFL players must be selected before endorsement of a permit in this case is considered and a maximum of twenty (20) players (including permit players) may be listed on the under 17 team sheet.

# **ONE GAME PER WEEKEND**

• A player playing on permit may play in only one game per weekend in any competition under the control of either league.

# REPORTED PLAYERS

- A player playing on permit who is reported shall face the Tribunal of the League in which the
  offence was committed. A suspended player is ineligible to apply for a permit until the period
  of suspension has ended.
- Any penalty that is imposed shall apply in all competitions of either league.

# **FINALS PERMITS.**

• No permits under this agreement shall be issued for players to play in the finals series of either league.

#### **APPENDIX 5:**

# AREA AGREEMENT between HDFL and Goulburn Campaspe Junior FL(GCJFL)

This agreement is signed pursuant to the Victorian Country Football League Incorporated Rules and Regulations pertaining to clearances and permits and in particular clause 2.10 whereby an interchange of players between Clubs of the above-mentioned Leagues may take place without clearance and is subject to any provisions contained within this agreement.

# PROVIDED HOWEVER

- That this Agreement is in force for the current season only with the agreement to be signed at the start of the year. Copies to be held by each League and club secretary.
- That the players involved desire to play with the club in the other League on the day in question.
- That the Clubs involved are agreeable to the players playing on the day in question.
- That the players concerned are acquainted with V.C.F.L. Regulation 2.0 regarding permits.
- That prior to playing their first game under this agreement, the player shall obtain permission to do so from his parent Club using the permit form provided with this agreement. Failure to do so may result in a penalty as deemed appropriate by league administration.
- Club registered players must be selected before permit players can receive endorsement to play.

# NUMBER OF PERMITS NOT SPECIFIED

- GCJFL Players may be granted by their clubs day permits to play in the HDFL during the HDFL home and away season provided that they meet any age requirement of the HDFL.
- Day permits can be issued if there are no more than 20 players listed (including permit players) on their Under 17 team sheet. Players may play TWO games per weekend.
- HDFL Players may be granted by their clubs day permits to play in the GCJFL during the GCJFL home and away season provided that they meet any age requirement of the GCJFL.
- Day permits can be issued if there are no more than **20 players listed (including permit players) on their team sheet**. Players may play **TWO games per weekend.**
- All teams are only permitted to play a maximum of SIX permit players in any one match.

#### **TRANSFERS**

- Transfers of players between the above-mentioned Leagues and Associations shall not close on the 1st day of July in the year of competition but be open for the whole of the Home and Away season.
- A player who seeks a clearance after the 1st of July must have completed 6 match permits. This clearance must be applied for before the Thursday prior to the commencement of the first finals game in either league. Once the player has been transferred after the June 30<sup>th</sup> date under these conditions, he cannot apply for a permit to play with his original club or any other club during the current season.

#### REPORTED PLAYERS

- A player playing on permit who is reported shall face the Tribunal of the League in which the offence was committed. A suspended player is ineligible to apply for a permit until the period of suspension has ended.
- Any penalty that is imposed shall apply in all competitions.

# **FINALS PERMITS.**

• No permits to be issued for players to play in Finals. At the completion of the season, any player transferred after the 1st of July shall be automatically transferred back to the club from which he received the transfer.

#### **APPENDIX 6:**

# AREA AGREEMENT between HDFL and North Central FL (NCFL)

This agreement is signed pursuant to the Victorian Country Football League Incorporated Rules and Regulations pertaining to clearances and permits and in particular clause 2.10 whereby an interchange of players between Clubs of the above-mentioned Leagues may take place without clearance and is subject to any provisions contained within this agreement.

# PROVIDED HOWEVER

- That this Agreement is in force for the current season only with the agreement to be signed at the start of the year. Copies to be held by each League and club secretary.
- That the players involved desire to play with the club in the other League on the day in question.
- That the Clubs involved are agreeable to the players playing on the day in question.
- That the players concerned are acquainted with V.C.F.L. Regulation 2.0 regarding permits.
- That all relevant persons complete a current permit form, and that this form is submitted to the league administration prior to the player playing their first permit game. Failure to do so may result in a penalty as deemed appropriate by league administration.
- Players of any club having a bye (including a split round) will be allowed to play with a club in the other league on that day.

# **NUMBER OF PERMITS**

- Two area permits may be granted for an HDFL player to play with an NCFL reserve grade team during the current season.
- Two area permits may be granted for an NCFL player to play with an HDFL reserve grade team during the current season provided the player is excess to the NCFL club needs and he has NOT played an NCFL senior grade game in the current or preceding season.
- Four area permits may be granted for an HDFL player to play with an NCFL under 16 team provided they are within the age group of the NCFL competition during the current season.
- Four area permits may be granted for an NCFL player to play with an HDFL under 17 team provided they are within the age group of the HDFL competition during the current season. All available registered HDFL players must be selected before endorsement of a permit in this case is considered and a maximum of twenty (20) players (including permit players) may be listed on the under 17 team sheet.

# ONE GAME PER WEEKEND

• A player playing on permit may play in only one game per weekend in any competition under the control of either league.

# **REPORTED PLAYERS**

- A player playing on permit who is reported shall face the Tribunal of the League in which the offence was committed. A suspended player is ineligible to apply for a permit until the period of suspension has ended.
- Any penalty that is imposed shall apply in all competitions of either league.

# **FINALS PERMITS.**

• No permits under this agreement shall be issued for players to play in the finals series of either league.

# **APPENDIX 7:**

# AREA AGREEMENT between HDFL and Shepparton and Districts Junior FL(S&DJFL)

This agreement is signed pursuant to the Victorian Country Football League Incorporated Rules and Regulations pertaining to clearances and permits and in particular clause 2.10 whereby an interchange of players between Clubs of the above-mentioned Leagues may take place without clearance and is subject to any provisions contained within this agreement.

# PROVIDED HOWEVER

- That this Agreement is in force for the current season only with the permit to be signed at the start of the year. Copies to be held by each League and club secretary.
- That the players involved desire to play with the club in the other League on the day in question.
- That the Clubs involved are agreeable to the players playing on the day in question.
- That the players concerned are acquainted with V.C.F.L. Regulations 2.1, 2.2 and 2.5 regarding one day permits.
- That all relevant persons complete a current permit form, and that this form is submitted to the league administration prior to the player playing their first permit game. Failure to do so may result in a penalty as deemed appropriate by league administration.
- Club registered players must be selected before permit players can receive endorsement to play.

# **NUMBER OF PERMITS**

- S&DJFL. Players may be granted by their clubs **six(6)** area **permits** to play in the HDFL under age competition during the HDFL home and away season provided that they meet the age requirement of the HDFL.
- Day permits can be issued if there are no more than **20 players listed (including permit players) on their Under 17 team sheet**. Players may play **TWO games per weekend.**
- HDFL Players may be granted by their clubs **six(6)** area permits to play in the S&DJFL during the S&DJFL home and away season provided that they meet any age requirement of the S&DJFL.
- Day permits can be issued if there are no more than **20 players listed (including permit players) on their Under 16 team sheet**. Players may play **TWO games per weekend.**
- If a player is to play more than the six permits they will require permission from the League he is registered with and the relevant Area Manager.
- All teams are only permitted to play a maximum of SIX(6) permit players in any one match.

# **TRANSFERS**

Transfers of players between the above-mentioned Leagues shall close on the 1st day of July of the current season

# REPORTED PLAYERS

- A player playing on permit who is reported shall face the Tribunal of the League in which the
  offence was committed. A suspended player is ineligible to apply for a permit until the period
  of suspension has ended.
- Any penalty that is imposed shall apply in all competitions.

# **FINALS PERMITS.**

• No match day permits shall be issued for S&DJFL players to play Major or District League Finals. At the termination of the season any player cleared after the 1st of July shall be automatically transferred back to the Club from which he received the clearance. As per V.C.F.L. clause 1.4.

#### **APPENDIX 8:**

# AREA AGREEMENT between the HDFL and the Seymour District Junior FL (SDJFL)

This agreement is signed pursuant to the Victorian Country Football League Inc. Rules and Regulations pertaining to Clearances and Permits and in particular clause 2.10 whereby an interchange of players between clubs of the above mentioned Leagues may take place without a Clearance and is subject to any provisions contained in this agreement.

# PROVIDED HOWEVER

- That this agreement is in force for the current season only.
- That the players concerned are acquainted with VCFL Regulations 2.1, and 2.5 regarding one day permits to Major Leagues and (8) matches.
- That prior to each match played, the players shall obtain a permit to do so from his parent club. The permit shall be in triplicate similar to a one day permit form and dispersed as required under Regulations 2.1 of the V.C.F.L. Rules and Regulations.
- With the exception of players of Junior age competitions, players of any club having a bye will not be allowed to play with another club on that day, unless he has previously played with that club in the current season under this agreement. The club playing the player from the other League shall show his registered club on the match team sheet. Players of third 18 teams of Senior Grade competitions are not to be classified as players of Junior age competitions.
- That this agreement cannot be altered unless agreed to by the Area Manager.

#### **NUMBER OF PERMITS**

- **SDJFL** Players may be granted **8** area permits to play in the HDFL during the **HDFL** home and away season.
- Day permits can be issued if there are no more than **20 players listed (including permit players) on their Under 17 team sheet**. Players may play **TWO games per weekend.**
- **SDJFL** Players may be granted further area permits (above the 8) to play in the HDFL during the HDFL home and away season following written approval from the SDJFNL Secretary or VCFL NE Area Manager.

#### FINALS PERMITS.

• No permits to be issued for SDJFL players to play HDFL Finals.

# GAMES PER DAY/WEEKEND

• Players are permitted to play more than 1 game per weekend.

# **NUMBER OF PERMITS**

• All teams are only permitted to play 6 permit players in any one match.

# REPORTED PLAYERS

• A player playing on permit who is reported shall face the Tribunal of the League of which the offence was committed. Any penalty that is imposed shall apply in all competitions.

#### PERMIT BREACHES

• Any breach of Permit arrangements and agreements will be referred to the VCFL under Rule 1.3.

#### **SPECIAL CIRCUMSTANCES:** Heathcote JFC and Heathcote FNC players only.

Heathcote players may be granted unlimited area permits to play in either the SDJFL or HDFL with Heathcote provide:
